Peer-to-peer invention based on a 7-year community-based participatory research project with federally subsidized childcare centers and a community advisory board. This intervention piloted in eight childcare centers and demonstrated high satisfaction among participants.
- 8. **Warren, J.** R. (2013). No Smokin' Hood: Motivating the unmotivated smokers to seek cessation treatment. Culturally, algorithmically, and aesthetically designed for Black smokers, the web-

based interface replicates an inner-city community (e.g., bank, health clinic, etc.) with messaging on the harms of smoking, financial burden of smoking, nicotine addiction, and environmental tobacco smoke placed throughout community sites. This intervention has a guided path for structure and a semi-guided path, and an unguided path, allowing degrees of navigational flexibility. Usability testing showed utility and relevance for potential users. Requires further development.

#### **Undergraduate Courses**

#### 1. Feminist Research Methods (Fall 2022)

Introduces feminist approaches to research for advanced undergraduate students. Focuses on the techniques for collecting and analyzing and examines central methodological issues raised by feminist scholars. Emphasizes a learning-by-doing approach to conducting research where this course facilitates an experiential learning opportunity. Throughout this course, we will collaborate on the development of an actual feminist research project, deploy it, and analyze and interpret the findings.

#### 2. Social Construction of Black Health (Spring 2022)

Social constructions are inherently situated within and shared through communication processes at the intrapersonal, interpersonal, communal, and organizational/institutional influenced macro-level influences, such as structural racism, which is also a social construction. #### 3. Foundations of Health Communication (Fall 2021; Spring 2021)

In this course we survey health communication theories, models, processes, strategies, and techniques as applied to public/community health, health disparities, and medical inequities and related to a variety of contexts. During the process of disseminating class material, student developed health communication interventions a the final project.

## 1. Special Topic Course: Health Literacy (Fall 2014, Spring 2016, Fall 2016)

This course used a service-learning approach that focuses on applying health literacy principles to real-life phenomenon, including clinical encounters, as well as community and public health contexts with an emphasis on medically underserved and vulnerable populations.

#### 2. Health Communication (Spring 2010, Fall 2011, Spring 2012, Fall 2012)

The overall goal of this course is to introduce you to relationships between health literacy and health communication as well as learn how to collaborate with a community organization to design nutritional health messages for use in REAL neighborhoods.

# 3. Communication and Social Change: Community Engagement (Summer 2011, Fall 2011, Spring 2012, Summer 2012)

This hybrid course draws upon methods from community-based participatory research and health contexts to situate our ecological explorations of community engagement. This course is appropriate for students who are interested in corporate social responsibility, research at the community level, or working in grassroots and community-based non-profits.

# 4. Special Topic Course: Communicating Community & Identity in Health (Summer 2011)

This is a hybrid course in applied health communication. We will review actual transcripts from focus group interviews involving people who smoke cigarettes to investigate and link process, context, and outcomes. Specifically, we will form a 'research team' to investigate how stories from these focus groups 1) build and reflect a working-class communal identity (i.e., process) and 2) link this group identification to personal health promotion (i.e., context) to 3) help shed light on challenges and assets in

quitting smoking for lower income smokers (i.e., outcomes).

## 5. Interpersonal Communication Theory (Fall 2009, Spring 2010)

This course explored how existing and new communication technologies facilitate and change interpersonal communication. In the process, this course provides theoretical and methodological foundations for investigating mediated interpersonal communication.

# 1.Decentralizing Academic Research: The Role of Community- Engaged Methodologies (Spring 2014) (Doctoral students)

This seminar interrogates what is viewed as valuable in academic research and present participants with interesting, evidence-based research models that seek to decentralize academic research by giving it back to the people we seek to study.

# 2. Experiences with Communication Participatory Research (CBPR; Spring 2014) (Doctoral students)

Students engaged in community-based project for experiential learning in the conduct of CBPR.

### 3. Special Topic Course: Community Health (Fall 2014) (Masters students)

This course is designed to introduce students to the field community-engaged prevention and methods of inquiry. By the end of this course, students will have an ecological understanding of the synergy between communication and community engagement in health and research, with an emphasis on health equity promotion. Students will apply this understanding to real world situations.

#### 4. E-Public Health Communication (Fall 2010, Fall 2012) (Masters students)

In this course, the user is the point of entry. Some call this consumer health informatics. This course applies an interdisciplinary lens and questions the status quo in e-health communication, especially at this relates to the underserved health consumer. In our exploration of communicating e- public health, we will go survey the process of planning, design, development, implementation, and evaluation in creating an evidence-based e- public health resource. Students will take away theoretical and applied understandings of inclusive e-public health communication.
